Commercial ENERGY STAR® Qualified Food Service Equipment Steps to Participation

1. DEMAND CONTROLLED KITCHEN VENTILATION:

Pre-Conditions:

New construction & retrofits qualify for this measure.

- Existing applications, the ventilation system has a constant-speed exhaust fan.
- New construction applications, there are no preconditions.

Post-Conditions:

- Controls the primary ventilation & make-up air units in the zone.
- Utilizes one or more control sensors to modify the fan speeds.
- One control sensor per fan horsepower.
- Multiple control sensors per fan horsepower.

2. ELECTRIC COMMERCIAL STEAM COOKERS

New construction & retrofits qualify for this measure.

- Installed equipment must be a minimum ENERGY STAR® v1.2 qualified.

3. HOT FOOD HOLDING CABINETS

New construction & retrofits qualify for this measure.

- Installed equipment must be a minimum ENERGY STAR® v2.0 qualified.
- Half Size <13.cu ft
- Full Size \geq 13 and <28 cu ft
- Double Size \geq 28 cu ft

4. ELECTRIC COMBINATION OVENS

New construction & retrofits qualify for this measure.

- Installed equipment must be a minimum ENERGY STAR® v2.2 qualified.
- Electric combination Oven 5 - 15 pan oven and/or 16 - 20 pan oven.

5. ELECTRIC CONVECTION OVENS

New construction & retrofits qualify for this measure.

- Installed equipment must be a minimum ENERGY STAR® v2.2 qualified.
- Half Size 18" x 13" x 1" pan size
- Full Size 18" x 26" x 1" pan size

6. COMMERCIAL ELECTRIC FRYERS

New construction & retrofits qualify for this measure.

- Installed equipment must be a minimum ENERGY STAR® v3.0 qualified.
- This measure is available for large-vat-size electric fryers only.

Documentation Requirements:

- The rebate application completely filled out & signed.
- Final invoice with equipment order/purchase date & installed cost.
- A copy of the ENERGY STAR® product list or ENERGY STAR® product packaging that shows the ENERGY STAR® logo (if applicable).
- You can expect to receive your rebate 8 to 10 weeks after the receipt of all required completed documentation.
- The rebate(s) will not exceed 70% of the installed cost.

All work must meet Bonneville Power Administration (BPA) and the City of Cascade Locks program and installation requirements.
